[7] Both parties relied in their briefs on Supreme Court Rule 2.140(g), which has since been repealed and replaced with Florida Rules of Judicial Administration 2.050(g). The rule provided: (g) Dismissal Without Prejudice. The appellate court may direct that the cause be dismissed without prejudice to its reassertion. In other cases the appellate court shall dismiss

the cause, but if, in the opinion of the appellate court, there is good ground for continuing the appeal, the order or judgment appealed from may be affirmed and the case remanded for further proceedings. [8] It appears that the appellant is relying on the following provision of the statute: "If... the state is a petitioner, on appeal the state shall be the appellant and shall be served with copies of all papers filed in the lower tribunal except when the

appellate court orders otherwise." § 39.02(5)(b), Fla. Stat. (1994). This provision may provide authority for a trial court to require the state to file a notice of appeal in a similar case, but it does not provide any authority for a trial court to dismiss a state's notice of appeal on its own initiative. [9] The state has not appealed from the trial court's order, so we express no
