conclude that neither of those  
circumstances is present here.

We first hold that the district court did not abuse its discretion when it imposed a 25-year mandatory minimum sentence for the § 924(c) offense. The district court's reasoning on this point was carefully stated. Applying the categorical approach, the district court observed that Banks' § 924(c) offense involved an attempt to inflict bodily injury with a dangerous weapon in furtherance of a crime of violence. The court noted that these elements were present in every case in which § 924(c) is charged and that it was not aware of any Tenth Circuit case

that had held that such conduct was not a crime of violence. The district court therefore held that the elements of § 924(c) were present in Banks' offense, and concluded that the 25-year mandatory minimum applied. We agree with the district court that Banks' crime of violence conviction under § 924(c) meets the elements-based approach. Banks was convicted of using a dangerous weapon to inflict bodily injury, and the government has not suggested that this conviction was somehow invalid. Thus, this case is governed by the Supreme Court's decision in
